A Letter from Wendy Brightman, President UMRC Foundation and Porter Hills Foundation

ori and Traci Potter began their careers as nurses. Experiences during their teenage years helped cement their passion of caring for older adults. While still in junior high, Traci helped care for an elderly neighbor when her family needed to be away, even learning to give her insulin. For Lori, losing her grandfather when she was seventeen was a pivotal moment. "I was close with my grandparents while I was growing up," says Lori. "I lived with my grandmother for two months after my grandpa died – it was just something I wanted to do."

With some 30 years' experience in senior living, Lori is a 13-year veteran of UMRC and serves as the Chief Operating Officer for UMRC & Porter Hills. Traci is the Administrator/Director of Nursing/Guide for UMRC & Porter Hills' Green House® Homes in Grand Rapids, a model for skilled nursing that embraces personcentered care, individual choices, and close personal attention for its residents.

"It feels like a family," says Traci. "It's a very supportive environment."

Lori appreciates the goals and guiding beliefs of UMRC & Porter Hills. "The mission isn't just something written on a wall; we actually live it out."

"The joy of working with older adults is not always recognized or appreciated by society as a whole," adds Traci. "Seniors are also underserved as far as philanthropy is concerned." It's why this couple has included the UMRC Foundation in their estate plan.

"I know the UMRC Foundation will follow through on what it says it will do with our gift," says Lori. Traci agrees. "If we can make a difference in an older adult's life and help them enjoy their later years, that's what we want to do."

Setting the PACE

Providing Innovative Care

hroughout the COVID-19 pandemic, UMRC's Huron Valley PACE (Program of All-inclusive Care for the Elderly) in Ypsilanti has created a variety of innovative ways to care for the nearly 200 low-income, nursing home-eligible older adults it serves.

One of fourteen PACE programs in Michigan, Huron Valley PACE is the only one that has continued to welcome participants, approximately ten per day, to its Day Health Center, including its clinic. This has been especially important for those living with dementia, according to Huron Valley PACE Executive Director, Sonja Love Felton. "Dementia doesn't take a break during COVID. It's very hard for families, even in the best of times, to care for their loved ones with dementia who may roam or become agitated. Huron Valley PACE has remained open to provide care and respite for our participants and families. Many simply don't have any other options for care for their loved ones."


To provide further support, Huron Valley PACE has offered overnight respite stays for eleven PACE participants so far. Tamara Kopins said, "The respite weekend my dad attended at Huron Valley PACE meant so much to us. He needed desperately to get out of the house and get some activity and social interaction, and it gave me a break I desperately needed. He loved his weekend! Thank you so much!"

The Huron Valley PACE team has greatly increased its in-home care and services in participants' homes. Donations of PPE and test kits have helped team members and participants maintain their health and safety.

Huron Valley PACE has also ramped up its telehealth capabilities, thanks to grants from the Michigan Health Endowment Fund and United Way of Washtenaw County. Says Sonja, "We are grateful for these donors who have made our work possible and eased our ability to safely serve and care for our participants."

UMRC Foundation & Porter Hills Foundation Announce Success of COVID-19 Emergency Fund, Safe Code of Conduct for Donor Visits

he UMRC Foundation and Porter Hills Foundation teams have proved they are stronger together, launching the COVID-19 Emergency Fund campaign and raising over \$1 million since the start of the pandemic in support of direct care team members at UMRC & Porter Hills. Already, over \$767,000 has been disbursed to help address the emergency needs of frontline team members shore to shore.

"As the COVID-19 pandemic began, UMRC & Porter Hills knew the strain this would put on our dedicated 'Healthcare Heroes' and their families," says Wendy Brightman, President of the UMRC Foundation and Porter Hills Foundation. "We wanted to do all we could to help our 740 direct care team members and honor the sacrifices they are making to provide extraordinary care for the older adults and families we serve."

Two anonymous matching grants of \$250,000 each were key in launching this initiative, says Wendy. "We are blessed to have such generous donors who believe in and support the excellent care and services our frontline team members provide every day to older adults. The matching aspect of their gifts encouraged others to give as well, and 25% of our gifts came from first-time donors. Each gift will serve the region the donor intended."

In addition, the UMRC Foundation and Porter Hills Foundation teamed up to create a *Safe Code of Conduct for Donor Visits*, offering opportunities to safely keep in contact with friends, donors, and residents. "The work we do is built on relationships," says Wendy. "It's so important to stay connected to those who support us, while also ensuring everyone's health and safety. Use of technology with Zoom and video calls, virtual coffee hours, and socially distanced visits allow us to stay in close contact."





hese days technology is keeping us more connected than ever! UMRC & Porter Hills is helping keep residents connected to loved ones during COVID-19 and to bring healthcare directly to PACE participants thanks to telehealth technology.

"Even before the 'Stay Home, Stay Safe' order was announced by the Governor, UMRC's IT team members were busy purchasing iPads that our residents could use to keep in touch with their families during quarantine," says Wendy Brightman, President of UMRC Foundation and Porter Hills Foundation.

A \$20,000 grant from the United Way for Southeastern Michigan has also provided funding for iPads and technology for our residents at The Thome Rivertown Neighborhood Affordable Assisted Living in Detroit as well as for other emergency needs.

In addition, the UMRC Foundation and Porter Hills Foundation received several gifts, including a \$50,000 grant from the Michigan Health Endowment Fund, to assist with launching telehealth at Huron Valley PACE in Ypsilanti, Thome PACE in Jackson, and LifeCircles PACE on the west side, with locations in Muskegon and Holland. Together, they serve older adults in 11 counties across Michigan.

"We are thrilled to receive this gift from the Michigan Health Endowment Fund to support the healthcare needs of the older adults we serve through PACE," says Wendy. "Our PACE participants live with a variety of chronic health conditions and behavioral health challenges. It is vital that we keep this vulnerable population as safe as possible from exposure to COVID-19, while still addressing their physical and mental health needs."

uring the COVID-19 pandemic, UMRC's Spiritual Life team has taken advantage of technology in a variety of ways to ensure that residents, team members, and families receive words of comfort and reassurance.

"The pandemic has shaped our lives in so many unexpected ways, including the ways we share our faith with each other," says Rev. Dr. Julie J. Kilmer, Director of Spiritual Life at UMRC's Chelsea campus. "More than ever, it is so important to find creative ways to be in fellowship with each other and to lift each other up."

The Spiritual Life team has provided words of hope via daily phone messages available to residents, families, and team members. Virtual worship services are offered for residents over their campus TV channel, while virtual support groups are available for team members who may be struggling during this time.

On May 14, the Spiritual Life team offered "A Time of Remembrance," a virtual memorial service to honor residents who have recently passed away, but whose families were unable to gather for funeral services because of COVID-19. Nearly 400 people watched the livestreamed service, including families and residents.

Kathy Gauger, volunteer chaplain and Prairie Cottages resident, says, "At such a difficult time for the world, the service was so beautifully done and spirit-filled. I reflected that it was, perhaps, because we are all grieving in so many ways and realize just how vulnerable those we love and we, ourselves, are. It is such a blessing to live and minister within a community that strives to be Christ-centered."

ennifer Shores, RN had only been the Director of Nursing at UMRC's Kresge Healthcare and Rehabilitation Center (Kresge Center) for five months when the COVID-19 pandemic hit.

"I was blessed to join a wonderful team at Kresge," says Jennifer. "It's a whole team effort here, from the scheduler to nurse managers to the CNAs. Day in and day out, our caregivers are doing amazing work. They are so invested in caring for our residents, and they've been so supportive of each other. Our Life Enrichment, Spiritual Life, and Dining teams have also been right there with us, helping provide more interaction and socialization for the older adults we serve."

While visitors are not yet allowed to the Kresge Center, Jennifer says their team members and residents' families are getting creative, helping with visits at residents' windows, facetime and phone calls, and delivering items to loved ones. "It's been hard for our residents to not see their families face-to-face, but it's also hard for our team members," says Jennifer. "Families are an integral part of our care teams, and we can't do it without them."

Jennifer adds, "Our Kresge Center team has felt the support of the entire organization. It's been amazing to have someone to comb through all the state and federal guidelines, or to track down the PPE that our caregivers so desperately need. We feel so supported by the UMRC Corporate office, the Human Resources team, and the UMRC Foundation in all they are doing to assist our direct care team members with emergency needs. In the end, it's all about having caring, compassionate team members who feel supported in their caregiving roles."
